Sample Matters

- Represented the prevailing landowners in the landmark land use case of Simplex Technologies, Inc. v. Town of Rye, 147 NH 558 (2002) clarifying the standard for the vesting of subdivisions and successive variance application, ultimately recovering damages and attorneys fees for the bad faith denial of vested land use rights.
- Served as co-counsel with David Gottesman, Esq. representing the family of Amy Lynn Boyer who was murdered by a cyberstalker in the case of Remsburg v. Docusearch, Inc., 149 NH 148 (2003) which established privacy standards for internet information brokers.

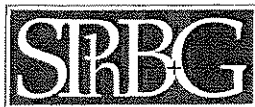
Memberships and Admissions
